Eligibility: Artists may submit a maximum of three (3) original 2D artworks for consideration. Artworks larger than 60in x 60in will not be accepted. Final 2D works must be “ready to hang”, framed or on a canvas with a horizontal wire across the back for hanging purposes. All accepted artworks must include a title, the artist’s name, price (or listed as not for sale). A short description is optional and can include a blurb about the artwork and social media handles. The Mable House Arts Center will make the final determination of display arrangement and reserves the right to not display all pieces submitted. All works must be original and made by the persons submitting. Acceptable works include: drawings, paintings, digital illustrations, collage, etchings, block prints, and photographs.

Delivery: Once an artist’s work has been accepted, they will have from January 8th-January 12th to drop off their work. Late submissions will not be accepted. Artists will be responsible for hand delivery of work to (and picked-up from) the Mable House Arts Center. The artist is responsible for any insurance on his/her work. No artwork is to be shipped directly to the Mable House Arts Center. **No group or school submissions please.**

Agreement: Submission of works to this exhibition constitutes agreement on the part of the artist to all terms and conditions of this entire prospectus, which includes, but is not limited to, the right of the Mable House Arts Center to use entries for publicity. Unless otherwise specified to the Mable House staff in writing by the artist, the artwork may be used for the Mable House publicity and archives. By submitting, the artist agrees that they own the artwork and have sole permission to submit.

Liability: Neither the Mable House Arts Center nor Cobb County PARKS (nor their employees, agents, officers) will be held responsible for lost or damaged artworks. The artist is responsible for any insurance on his/her work during the exhibition. While utmost care is given to all entries, Mable House and Cobb County PARKS do not assume any liability for damage or loss, before, during or after the exhibition.
